## WE TAKE CARE OF YOUR HEALTH AND WELL-BEING WITH PREVENTIVE CARE

You are eligible for the University of Miami's Preventive Care Medical Plan from UnitedHealthcare.

- You may enroll yourself and your eligible dependents in the preventive plan on your date of hire, during Open Enrollment or if you experience a life event during the year.
- The plan covers preventive care only. Preventive care includes services like annual physicals, well woman exams, mammograms, and colonoscopies. If you receive a preventive care service in the United Healthcare network, you'll pay \$0 for that service (not including your monthly premium).
- The plan does not cover expenses when you are sick. Expenses for sick visits including outpatient surgeries, hospitalizations, and visits to the doctor for anything other than annual preventive care are not covered.
- Pharmacy expenses are not covered.
